TRIPURA BILL NO.08 OF 2020.

THE TRIPURA APPROPRIATION (NO.08) BILL, 2020. A BILL

to authorize payment and appropriation of certain further sums from and out of the Consolidated fund of the State of Tripura to meet the expenditure incurred on certain services during the financial year ended on 31st March, 2015 in excess of the amount granted for those services and for that year.

BE it enacted by the Legislative Assembly of Tripura in the seventy first year of the Republic of India as follows: -

Short Title & Commencement

- 1. i) "This Act may be called the Tripura Appropriation (No.08) Act, 2020".
 - They shall come into force on and from the date of their publication in the official Gazette.
- Issue of

From and out of the Consolidated Fund of the State of Tripura, the sum specified in column 3 of the Schedule amounting in the aggregate to the sum of Rupees seventy one crore sixty lakh thirty six thousand five hundred fifty four only shall be deemed to have been authorized to be paid and applied to meet the amount spent for defraying the charges in respect of the services specified in column 2 of the Schedule during the financial year ended on the 31st day of March, 2015 in excess of the amounts granted for those services and for that

Appropriation

3. The sums deemed to have been authorized to be paid and applied from and out of the Consolidated Fund of the State of Tripura under this Act should be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March, 2015.

TECHNICAL REPORT

This is Money Bill within the meaning of Article 199 of the Constitution of India.

The Bill attracts the provisions of Article 207 of the Constitution of India. Therefore, recommendation of the Governor is necessary for both introduction and consideration of the Bill in the Tripura Legislative Assembly.

The State Legislature has exclusive power to enact a law on the subject.
