BE it enacted by the Legislative Assembly of Tripura in the sixty-seven year of the Republic of India as follows: -

Issue of a sum of Rs.28,28,22,000/- out of the Consolidated Fund of the State of Tripura for the Financial Year 2015-16.

 - 2. From and out of the Consolidated Fund of the State of Tripura, there may be paid sums not exceeding those specified in column-3 of the Schedule amounting in the aggregate to the sums of Rupees twenty-eight crore twenty-eight lakh twenty-two thousand only towards defraying the several charges which will come in course of payment during the financial year 2015-2016 (hereinafter referred to as the said year) in respect of the services and purposes specified in column-2 of the said Schedule.
