#### NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 of the Constitution, the Governor, Tripura hereby makes the following rules regulating the method of recruitment to the post of **Staff Nurse** under the Health & Family Welfare Department, namely :-

**1. Short title and commencement :-**

- (i) These rules may be called the Recruitment Rules of Staff Nurse under the Health & Family Welfare Department, Government of Tripura ;
- (ii) They shall come into force on the date of publication of these rules in the Official Gazette.

**2. The name of the post shall be specified in Sl. No. 1 of the Schedule annexed hereto.**

**3. Number, classification and scale of pay :-**

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Sl. No. 2 to 4 of the Schedule annexed hereto.

**4. Method of recruitment, age limit, qualification etc. :-**

The method of recruitment to the said post, age limits, qualifications and other matters relating to the said post shall be as specified in Sl. No. 5 to 13 of the said Schedule.

**5. Disqualification :-**

- No person – (a) who has entered into or contracted a marriage with a person having spouse living ; or
- (b) who, having a spouse living has entered into or contracted a marriage with another person, shall be eligible for appointment to the said post.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

**6. Power to relax :-**

Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

**7. Savings :-**

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.


1. Name of the Post :- **STAFF NURSE**
2. Number of the Post(s) :- 2678 (two thousand six hundred seventy eight) plus additional posts as and when created
3. Classification :- Group - C, Non-Gazetted
4. Scale of Pay :- Pay Level - 10 under Tripura State Civil Services (Revised Pay) Rules, 2017 read with its amendment(s) subject to revision from time to time.
5. Method of recruitment whether by direct recruitment or by promotion or by transfer on deputation and percentage of the vacancies to be filled by various methods :- 100% by direct recruitment through written test only. Total marks of examination will be 100. Questions will be objective/short/MCQ type in English language on the following subjects :-

Examination shall be conducted by the separate institution to be constituted according to new recruitment policy issued by the GA (P&T) Department's Notification No. F.20(1)-GS(P&T)/18, dated 5<sup>th</sup> June 2018.

6. Age limit for direct recruitment :- 18 to 40 years. Upper age limit relaxable by 5 years for SC, ST, PH, Ex-serviceman and Government Servants.
7. Education and other Qualifications required for direct recruitment :- (a) Diploma in General Nursing & Midwifery (GNM)  
OR  
B.Sc. in Nursing  
(b) Having registration under Tripura Nursing Council as Registered Nurse & Registered Midwife (RNRN)
- Note :- Candidates having degree in nursing (B.Sc. Nursing / Post Basic B.Sc. Nursing) shall be given 1 (one) additional increment.
8. Whether age and educational qualifications prescribed for direct recruits will apply in case of promotion :- Not applicable
9. Whether Selection post or Non-selection post :- Selection post.
10. Period of probation, if any :- 2(two) years
11. In case of recruitment by promotion / transfer on deputation, grades from which promotion / transfer on deputation is to be made :- Not applicable
12. If a DPC exists, what is its composition? :- Not applicable
13. Circumstances in which TPSC is to be consulted in making recruitment :- Not applicable
