#### NOTIFICATION

In exercise of power conferred by the provision to article 309 of the Constitution of the India the Governor of Tripura is pleased to make the following rules regulating the method of recruitment to the post of System Analyst for Agartala Municipal Corporation under Urban Development Department, Government of Tripura namely:-

#### 1. Short title and date of commencement:

- (a) These rules may be called as Recruitment Rules for the post of System Analyst in Agartala Municipal Council under Urban Development Department.
- (b) These shall come into force on the date of their publication in the official Gazette.
- 2. The name of the post(s) is/are specified I Column- 1 of the annexed Schedule.

#### 3. Number, Classification and scale of pay:

The number of the said post, its classification and the scale of pay attached thereto are specified in Column 2 to 4 of the schedule annexed hereto.

## 4. Method of recruitment, age limit, qualification etc.

The method of recruitment to the said post, age limit, qualification and other matters relating to the said post shall be as specified in Columns 5 to 13 of the said schedule annexed hereto

# 5. <u>Disqualification</u>: No person

- (a) who has entered into or contracted a marriage with a person having spouse living, or
- (b) Who having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of these rules.

#### 6. Power to relax

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing may relax any of the provisions of these rules with respect to any class or category of persons.

### 7. Savings

Nothing in these rules shall effect reservation, relaxation of age limit and other concessions required to be provided for the scheduled Caste, the schedule Tribes, Exservicemen and other special categories of persons in accordance with the order issued by the State Government from time to time in this regard.
