## NOTIFICATION

In exercise of the power conferred by proviso to article 309 of the Constitution and in supersession of the existing Recruitment Rules for the post mentioned herein, the Governor hereby makes the following rules regulating the method of recruitment to the post of Professor, Technical (Engineering) Degree Colleges under Education (Higher) Department namely:-.

- 1. Short title and date of commencement :-
  - (a) These rules may be called "Recruitment Rules, 2011" for the post of Professor, Technical (Engineering) Degree Colleges under Education (Higher) Department.
  - (b) They shall come into force on the date of their publication in the Official Gazette.
- 2. The name of the post(s) shall be specified in Column 1 of the schedule.
- 3. Number, Classification and scale of pay:

The number of the said post, its classification and the scale of pay shall be as specified in columns 2 to 4 of the Schedule annexed hereto.

4. Method of recruitment, age limit, qualification etc.

The method of recruitment to the said post, age limits, qualifications and other matters relating to the said post shall be as specified in columns 5 to 13 of the said schedule.

- 5. Disqualification:- No person.
  - (a) Who has entered into a contracted a marriage with a person having spouse living; or
  - (b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible or appointment to the said post.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rules.

**6. Power to relax:** Where the State Government is of the opinion that it is necessary or expedient to do so, it may, be order, for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, may relax any of the provisions of these rules with respect to any class or category of persons or post.

## 7. Repeal and saving:

- (i) The existing Recruitment Rules for the post of Professor, Technical (Engineering) Degree Colleges vide No. F.1(675)-DHE/Estt(G)/2007 dated 27-08-2007 shall stand repealed.
- (ii) Notwithstanding such repeal any appointment made or order issued, action taken or anything what so ever done under the rules so repealed shall be deem to have been made, issued taken or done under the corresponding provision of these rules.

### **EXPERIENCES**

Maximum of 13 years experience in teaching and / or Research and / or Industry.

In case of Research experience, good academic record and books / research paper publications, IPR / patents record shall be required as deemed fit by the expert member of the Selection Committee. If the experience in Industry is considered, the same shall be at managerial level equivalent to Associate Professor with active participation record in devising / designing, planning, executing, analyzing, quality control, innovation, training, technical books / research paper publications / IPR / patents, etc. as deemed fit by the expert members of the Selection Committee.

In case of Architecture, Professional practice of 10 years as certified by the Council of Architecture shall also be considered valid.

- A. i) An eminent scholar with Ph. D qualification(s) in the concerned / allied / relevant discipline and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 publications as books and / or research / policy papers.
- ii) A minimum of ten years of teaching experience in University / College, and / or experience in research at the University / National Level Institutions / Industries, including experience of guiding candidates for research at doctoral level.
- iii) Contribution to educational innovation, design of new curricula and courses, and technologymediated teaching learning process.

iv) A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal system (PBAS), set out in UGC Regulation in Appendix - III.

B. An outstanding Professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned / allied / relevant discipline, to be substantiated by credentials.
