### NOILEICATION

In exercise of the powers conferred by proviso of Article - 309 of the Constitution and in supersession of the existing Recruitment Rules for the post Naiks (Armed) Men and Women the Governor is hereby pleased to make the following amended Rules regulating the method of Common Recruitment to the post of Naiks (Armed) Men & Women, Police

- Short title and commencement :-
  - These rules may be called "Recruitment of Naik (Armed) Men & Women,
  - They shall come into force on the date of their publication in the Official (2)
- 2. Name of the Post:

The name of the post shall be specified in Serial No.1 of the schedule annexed

Number of Posts, Classification & Scale of Pay: 3.

Total number of posts, classification and scale of pay thereto shall be as specified in Serial No.2 to 4 of the Schedule.

Age, Educational &Other Qualifications: 4.

Age limit, educational and other qualification required for the direct recruitment shall be specified under Serial No. 6 to 8 of the Schedule annexed hereto.

5. Method of Recruitment, promotion:

The method of Recruitment to the post shall be as specified under SI No.10 to 11 of the Schedule annexed hereto.

(ii) Disqualification -

No person -

- who has entered into or contracted a marriage with a person having spouse (a)living; or
- who, having a spouse living has entered into or contracted a marriage with (b) any person shall be eligible for appointment to the said posts.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and they other partly to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- Power to relax: Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, relax of the provisions of this Etuie with respect to any class or category or persons.
- Other concessions required to be provided for the Schedule Castes, the Schedule Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the State Government/ Government of India from time to time in this regard. The post of Naiks (Armed) Men and Women shall be governed by the PRB 1943 as adopted by the Government of Tripura.
