NOTIFICATION

In exercise of the powers conferred by provision to article 309 of the constitution in the supersession of the recruitment rules fot the post mentioned herein, the Governor, Tripura hereby makes the following rules regulating the method of Recruitment to the post of Senior Chemist, under the Health & Family Welfare Department, namely:-

- 1. Short Title, Commencement:-
 - (i) These rules may be called, as the Recruitment Rules for the Post of Senior Chemist, under the Health & Family Welfare Department Govt. of Tripura, Agartala.
 - (ii) This rules shall come into force on the date of their publication in the official gazette.
- 2. The name of the post shall be as specified in coloumn 1.
- 3. Number, classification and scale of pay:-

The number of the said post, its classification and the scale of pay attached thereto shall be specified in columns 2 to 4 of the Schedule Annexed hereto.

4. Method of recruitment, age limit. Qualification etc. :-

The method of recruitment to the said post, age limit, qualification and other matter relating to said post shall be as specified in columns 5 to 13 of the said schedule.

- 5. Disqualification:- No person -
 - (a) Who has entered into or contracted a marriage with a person having spouse living, or
 - (b) Who having a spouse living has entered into or contracted marriage with any person shall be illegible for appointment to the said post.

Provided that the State Government may, if satisfied that such marriage is permissible under the personal Law applicable to such person and the other party to the marriage and there are other grounds for doing, so except any person from the operation of these rule.

- 6. Power to relax: Where the State Government is of the opinion that it is necessary or expedient to do, so it may be order for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, relax any of the provisions of these rules with due regards to any class or category of persons.
- 7. Saving:- Nothing in those rules shall effect reservation, relaxing of age limit and concessions required to be provided for Schedule Caste, Schedule Tribes, Ex-Serviceman and other special category of person in accordance with the orders issued by the State Government from time to time in this regard.
