NOTIFICATION

In exercise of the power conferred by proviso to article 309 of the Constitution, the Governor, Tripura hereby makes the following rules regulating the method of recruitment to the post of Deputy Director, Chemistry Division (Chemical Science) in State Forensic Science Laboratory, Tripura under Home Department, namely:-

- 1. Short title & commencement :--
- (1) These rules may be called the "Recruitment Rules, 2012" for the post of Deputy Director, Chemistry Division (Chemical Science) in State Forensic Science Laboratory under the Home Department.
- (2) They shall come into force with effect from the date of its publication in the Tripura Gazette.
- 2. The name of the post(s) shall be as specified in Column-1 of the Schedule annexed hereto.
- Number, Classification and scale of Pay:--

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule, annexed hereto.

- 4. **Method of recruitment, age limit, qualification, etc:-** The method of recruitment to the said post, age limit, qualifications and other matters relating to the said post shall be as specified in columns-5 to 13 of the said schedule.
- 5. Disqualification: No person,
 - (a) Who has entered into or contracted a marriage with a person having spouse living; or
 - (b) Who, having a spouse living, has entered into or contracted a marriage with another person, shall be eligible for appointment to the said post:-

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any correspond from the operation of this rules.

6. Power to relax: Where the State Government is of the opinion that it is necessary or expedient to be a first by order, for reasons to be recorded in writing and in consultation with the 'Tripura Plant Service Commission', may relax any of the provisions of these rules with respect to any pass or passers of persons.

7. Saving:- Nothing is these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

Masters degree in Chemistry/Forensic Science with chemistry as one of the subject at Bachelor of Science level from a recognized university or equivalent.

Experience :-

- (i) Minimum 6(six) years working experience in the post of Senior Scientific Officer in a Government Forensic Science Laboratory in Chemical Science Division.
- (ii) Training in Forensic Chemical Sciences (ND & PS, Explosive and Toxicology) R&D activities in Forensic Science.

9. Period of probation, if any.

:- 2 (two) years.

10. Whether Selection post or non-selection post.

:- Selection.

11. In case of recruitment by promotion/deputation/transfer, Grades from which promotion/transfer/deputation is to be made.

Promotion from the post of Senior Scientific Officer of State FSL, Tripura who have completed 6 (six) years of service in the grade/discipline.
