Provision of financial assistance in the form of Pension to the accredited Journalists/photojournalists of the State keeping in view the services rendered by them has been under consideration of the Government.

- 2. After consideration of relevant issues, it has been decided to launch the "Scheme for Pension Benefits to the Journalists/photojournalists", the salient feature of which will be as follows:
  - i) He /She should have attained 60 years of age and have retired from the job of a journalist/ photojournalist.
  - ii) He /She must have put not less than 10 years of service as Journalists/Photo Journalists in the State.
  - iii) He /She should have a valid Accreditation Card issued by the ICA Department, Government of Tripura on the date of his or her retirement.
  - iv) He /She does not draw any pension from any other source except under Employees Provident fund (EPF).
  - v) The eligible pensioner will continue to receive pension unless he/she becomes ineligible.
  - vi) Accredited Journalists/photojournalists having requisite eligibility will be required to submit applications for the pension in prescribed format (enclosed) to the Director of Information, I & CA Department, Government of Tripura along with necessary declarations and certificates

vii) The Director of Information and Cultural affairs, Government of Tripura shall be the sanctioning authority.

(viii) The Scheme shall come into force with effect from the 1st day of May , 2012 .
