The Governor has been pleased to revise the existing guideline of the Indira Gandhi National Old Age Pension Scheme, Un-Employment Allowance to the 100% blind, Pension to the Rickshaw Pullers & Scheme for Tripura Cobbler Pension with following charges.

- Indira Gandhi National Old Age Pension Scheme. -
  - The age of the pensioners under Indira Gandhi National Old Age Pension scheme is reduced to 60 years & above from 65 years & above w.e.f. 01-04-2011.

The applicant must belong to a house hold of Below Poverty Line. b) c)

- The central assistance under IGNOAPS will be provided at the rate of Rs. 200/per month per beneficiaries who are in the age group of 60-79 years and @ Rs.500/- per month per beneficiary for those who are 80 years and above.
- Un-Employment Allowance to the 100% Blind. 2)

The rate of Un employment Allowance would be Rs. 1000/- (Rupees one thousand) per month for the 100% blind Un-Employed persons who are under BPL Families and Rs.500/- per month for those 100% blind Un-Employed persons who are above poverty line w.e.f. 01-04-2012. The amount would be paid to those who have educational qualification up to class VIII pass and registered into the Employment Exchange at least 2 years before and this allowance would be paid for 5 years.

- Pension to the Rickshaw Pullers. 3)
- The age for getting pension under this scheme is reduced to 55 years & above w.e.f. a)
- The rate of pension would be increased to Rs. 400/- (Rupees four hundred) from 300/- per b) month w.e.f. 01-05-2012. c)

The applicant must belong to a house hold Below the Poverty Line. d)

The applicant should submit a certificate issued by CEO/EO of the respective AMC/NP indicating that the applicant is a rickshaw puller by profession. In Case of licensed rickshaw puller belongs to rural area, a certificate from the local Gaon Panchayat or ADC Village Committee should be submitted. e)

Attested copy of an age proof certificate issued by AMC/NP/GP/Village Committee of TTAADC

- 4) Scheme for Tripura Cobbler Pension.
- a) Persons actually engaged in the profession of cobbling are eligible for cobblers' pension in the age group of 60 yrs & above.
- b) The rate of pension would be increased to Rs. 400/- (Rupees four hundred) from 300/- per month w.e.f. 01-05-2012.
- c) The applicant must belong to a house hold Below the Poverty Line.
- The applicant should submit a certificate issued by CEO/EO of the respective AMC/NP indicating that the applicant is a cobbler by profession. In case of cobbler belongs to rural area, a certificate from the local Gaon Panchayat or ADC Village Committee should be submitted.
- e) Attested copy of an age proof certificate issued by AMC/NP/GP/Village Committee of TTAADC areas should be submitted.
- Only one pension to be given to each person.

- 1) Pension to the un-married women of the age of 45 yrs & above under BPL families.
- i) The age of the un-married women must be 45 years & above.
- ii) The un-married women must be under BPL family.
- iii) The rate of pension will be Rs. 400/- (Rupees four hundred) per month w.e.f. 01-04-2012.
- iv) The pension is to be credited in to a public sector bank account of the beneficiary.
- v) The pension will be discontinued if there is the case of marriage or once the women moves above the poverty line.

PENSION SCHEME FOR UNMARRIED WOMEN OF 45 YEARS OF AGE AND ABOVE OF

Name of the Scheme: Pension Scheme for Unmarried Women of the age of 45 years and above and belonging to BPL families.

Sponsored by:

State Government.

Funding Pattern: 100% Fund to be financed by the State Government.

Ministry/Department:

Social Welfare & Social Education.

Description: A Pension Scheme for Unmarried Women of the age of 45 years and above and belonging to BPL families is propose to implement by the Department of Social Welfare & Social Education, Government of Tripura. The Assistance of Rs. 400/- per month is propose to give to the BPL/BPL-Listed unmarried women of the age of 45 years and above. The applicant should be a household below the Poverty Line as per criteria prescribed by the Government of Tripura. The State Government is urged to provide pension of an amount of Rs. 400/- per month per beneficiary. The pension is to be credited into a public sector bank account of the beneficiary. The pension will be discontinued if there is the case of marriage or once the women moves above the poverty line.

Beneficiaries: Women in the age of 45 years and above.

Benefit Type: Pension on monthly basis.

Eligibility criteria: The age of the unmarried women should be of 45 years and above belonging to Below the Poverty Line (BPL).

How to Avail: The Gram Panchayats/Nagar Panchayats/Municipalities are expected to identify the beneficiaries under the scheme. The number of eligible beneficiaries is determined according to the field report of all the beneficiaries who satisfy the eligibility criteria. The DM & Collectors are required to furnish a certificate that all eligible women have been covered under the scheme.

Disbursement: The disbursement of the amount would be made monthly basis through Bank Account by the Child Development Project Officers of Social Welfare & Social Education Department in each month after sanction is made.

Evaluation: Evaluation of the implementation of the Scheme would taken up yearly by the District Inspectors of Social Education of Social Welfare & Social Education Department or
